## Vehicle taxation

Your car, van or motorcycle's MOT expiry date will be extended by 6 months if it's due on or after 30 March 2020 - but you must keep your vehicle safe to drive. <u>https://www.gov.uk/guidance/coronavirus-covid-19-mots-for-cars-vans-and-motorcycles-due-from-30-march-2020</u>

### NHS support for extremely vulnerable patients:

NHS England and NHS Improvement are also setting up a new volunteering portal for very vulnerable patients to access support for daily tasks. This will be available from Tuesday 24 March. Given capacity, only the highest risk patients should be directed to this service.

Patients who do not have family or friends that can help, can also be directed to <u>www.gov.uk/coronavirus-extremely-vulnerable</u> to register for additional support with daily living tasks such as shopping and social care.

# **Grants and funding**

## **GLA & City Bridge**

the new **London Community Response Fund** in response to the Covid-19 crisis is now open for applications.

#### What funding is available?

- <u>Flexible grants of up to £5,000</u> are available to VCS organisations to cover the costs they're incurring whilst supporting communities affected by COVID-19 and the impact of stricter social distancing and isolation measures with a focus on food and other essentials.
- The collaborating funders (including the GLA and City Bridge), have agreed <u>a set</u> of principles which will underpin all the activities of the London Community Response Fund.
- There is a weekly rolling deadline for grant applications until further notice e.g. applications submitted by Friday 3rd April will be assessed in the following week.
- Wave 1 small grants are intended to enable VCS organisations to cover the additional expenditure meeting short-term needs around food and essential items such as mobile phones and data, and cleaning products.
- Please note, Wave 1 small grants cannot be used for staff costs or laptops.

#### Who is eligible?

Wave 1 small grants are only available to following organisation types (individuals are not eligible):

- Registered charity
- Registered Community Interest Company (CIC)
- Registered Charitable Incorporated Organisation (CIO)
- Charitable company (limited by guarantee)

#### How to apply?

#### Submit an application here

Applications will be shared with multiple funders who are collaborating on the London Community Response Fund. Applications will be screened to check they meet the eligibility criteria and then shared with the group of collaborating funders. Funders will select applications they are able to fund (depending on their area of operation and interest) and make decisions on them. Funders are committing to make decisions within a week.

#### What further funding will be available?

A second wave of funding in early April for larger grants, service transformation costs, and ongoing work to support communities. Applications for Wave 1 small grants will not prevent organisations applying for future rounds of funding.

## **United In Hammersmith & Fulham**

In light of the Coronavirus (Covid-19) emergency, United in Hammersmith & Fulham are offering grants to locally based non-profit organisations dealing with the effects of this emergency. This includes frontline groups who are working with people who face risk as a result of Coronavirus in Hammersmith & Fulham and those whose vital services are affected by the social distancing and self-isolation measures in place. This has made possible by the recent inpouring of generosity to our public Appeal.

The UNITED in Hammersmith & Fulham Coronavirus (Covid-19) Community Fund is now LIVE and grants of £100-£1000 can be applied for online at this link - <u>https://unitedhf.org/grants/apply/covidhf/</u>.

## **Arts Council England**

Arts Council England has set up a GBP160 million emergency support package to help the cultural sector deal with the coronavirus outbreak. See: <u>https://www.artscouncil.org.uk/covid19</u>.

This emergency response package includes GBP20 million for "creative practitioners and freelancers", with artists and workers in the cultural sector eligible for cash grants of up to GBP2,500. There will also be GBP50 million for organisations that are not in Arts Council England's portfolio, with grants up to GBP35,000. A further GBP90 million will be available next month for organisations in Arts Council England's portfolio and current grants will be advanced by up to six months to help with cash flow.

### **Money Saving Expert Grant**

MSE is releasing £1,000,000 to provide grants of £5,000 to £20,000 to small registered charities, or local arms of bigger charities, across the UK – to help with specific UK coronavirus-related poverty relief projects.

Examples could include foodbanks, charities engaged in community aid, financial advice help and more. MSE aims to get the money distributed within the next couple of weeks, and is looking for projects that are up and running, or are in the process of being set up – as we want to deliver help at speed.
